WHY I SUPPORT THE FOUNDATION

Mary Kay Linke is a longtime supporter of the St. Peter's Health Foundation. A Radiologic Technologist who has worked at St. Peter's Health in CT/MRI for 14 years, she has seen all the important ways the Foundation's work can impact people's lives.

"I give because many people need help and I want to be a part of helping relieve even a little bit of stress in what is usually a terrible part of someone's life," Mary Kay said.

The importance of giving was reinforced when her husband was diagnosed with cancer almost seven years ago.

Mary Kay's husband underwent multiple surgeries and procedures in several different hospitals around the country to deal with complications from the disease. The last surgery took place in Cleveland, where they stayed for three weeks while her husband recovered from surgery at Cleveland Clinic.

Patient assistance funds from the Foundation helped pay for a long list of items during their stay, including transportation, food and other travel-related expenses.

"It just took weight off," Mary Kay said of the funds. "We didn't have to put it on a credit card or worry about it when we got back from this stressful trip."

Although Mary Kay and her husband were initially reluctant to apply for assistance, the funds from the Foundation were "such a gift," providing much needed support for her husband and helping to ease the burden for Mary Kay as the caregiver.

"In these situations people want to help," she said. "They often will ask 'what can I do?' 'how can I help?' By giving to the Foundation, those questions are answered in a tangible way; and one of the best things is that you help people that you don't even know need it."



2019 FOUNDATION EVENTS

Pinwheel Pledge

In 2019, the Foundation expanded the Pinwheel Pledge campaign to include the organization's Women and Children's Unit, Behavioral Health Unit and Dialysis Unit in addition to the Cancer Treatment Center.

"We heard from our caregivers that patients receiving care for a variety of reasons would benefit from the funds raised through the campaign," said St. Peter's Health Foundation Project Manager Bennett MacIntyre. "Proceeds go directly to support patients. Whether it is unexpected travel expenses for a cancer survivor, compression garments for a dialysis patient or nutrition supplements for a new mother, we know that anything we can do to help patients during what is already a stressful time can be life-changing."

In 2019, \$25,082 was raised by 275 donors.

Golf Tournament

The 2019 golf tournament was once again the premier fundraising golf outing of the summer in the Helena area. Dick Anderson Construction graciously continued its support as Presenting Sponsor.

The golf tournament sold out and raised over \$75,910. Golfers were treated to a band on the patio of the Green Meadow Country Club after

the round as well as many games and prizes on the course. Money raised from the event in 2019 went directly to the patient assistance fund.

Light A Life

Many people don't realize that individuals can receive hospice care even if they are in a skilled nursing facility. They also don't know that when a condition isn't getting worse, individuals can graduate from hospice. As this year's Light A Life spokesperson Mary Runkel shared, her mother's disease progressed over a period of seven years—her mother was in hospice three times, graduating twice. Gifts to St. Peter's Health Hospice make this wonderful care available to everyone, regardless of ability to pay. These funds also help train staff and volunteers on the best ways to provide this compassionate end-of-life care.

In 2019, \$75,248 was raised from 859 donors.

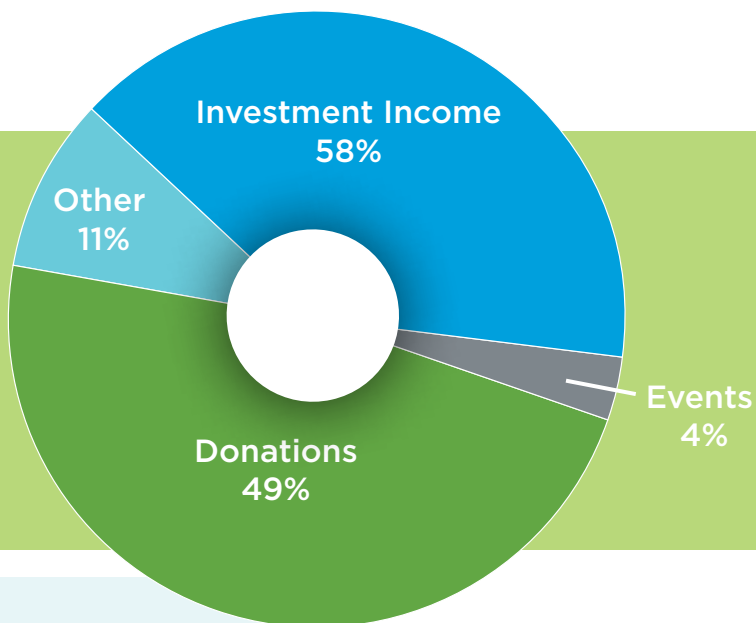
